### HANCOCKS DRAINAGE & BUILDING SUPPLIES LTD SALE TERMS

#### GENERAL

These terms of sale shall apply to all trading between Hancocks Drainage and Building Supplies Ltd and the customer. By placing an order with us, you agree to accept these terms, as well as our privacy policy and terms of website use.

### PRICING

We list all our prices both exclusive and inclusive of VAT. Please note all prices are subject to change as appropriate so please carefully check prices before placing your order. If a price has been added to the system incorrectly on our website and the correct price is lower, we will charge you the correct price when processing the order. However, if the correct price is higher than our listed price, we are under no obligation to provide the product at the lower price and will notify you of this.

### **DELIVERY/DELIVERY COSTS**

We operate our deliveries using a 7.5 ton lorry with crane and will deliver within a 15 mile radius direct from our branch using our vehicle.

We advise that customers wait for their goods to be delivered before arranging for work to be undertaken. We cannot offer any form of compensation due to orders being late.

Non-Account customers

Delivery will be free on all orders when you spend over £125 + VAT within a 5-mile radius.

Standard orders under £125 + VAT will incur a £20.00 delivery charge

The following delivery charges will apply for deliveries over 5 miles

5-10 miles under £250 + VAT – delivery charge of £25.00

10-15 miles under £325 + VAT – delivery charge of £35.00

On orders over 15 miles there will be a delivery charge advised upon application

Delivery direct from suppliers – there will be a delivery charge on application depending on supplier and products ordered.

## PLACING YOUR ORDER

You must accept these terms in full before your order can be placed and you must be aged 18 and over to place an order with us. Please check your order before placing and ensure that you provide us with your correct telephone number and email address.

## PAYMENT

You can only pay for products ordered through the website by debit or credit card. We accept Visa and MasterCard. We will take payment for your order including delivery charges from your credit or debit card once you place your order. If we cannot fulfil your order for any reason, we will notify you and provide you with a refund to the card you made payment with

## ACCEPTANCE OF ORDER

Your order will be confirmed by an email once placed and providing payment has gone through successfully. However, if we cannot fulfil your order once placed for any reason in particular stock availability, we will contact you as soon as possible. If we cannot contact you about any out-of-stock items we will accept your order for the products we do have in stock. We will of course give you a refund for any items not available.

## TIMESCALE FOR DELIVERY

We will aim to deliver your order within 2 working days unless otherwise advised and will email you with a confirmed delivery window on placement of order

All deliveries must be received and signed for by a person aged 18 or over.

## FAULTY PRODUCTS

## **CONSUMER CANCELLATION RIGHTS**

To exercise your rights under Consumer cancellation you must contact us any time before the products are dispatched or within 14 days from the placement of the order. If you exercise your consumer cancellation rights after delivery you will be responsible for returning the products to us at your cost and within 14 days of cancelling your order.

We will refund your returned products as soon as possible after receiving them back. The refund will be made back to you debit or credit card the order was paid with. We have the right to reduce the amount of the refund for any damage or depreciation in value of items that has resulted whilst goods have been in your care
